

Cookie Policy

1. Introduction

This Cookie Policy applies to the website www.cit-one.ro, operated by **CIT ONE S.A.**, and forms an integral part of the Privacy Policy.

The website uses cookies and similar technologies to ensure the proper functioning of its pages, to store user preferences, and to comply with legal obligations regarding the management of consent for non-essential cookies.

2. What do we use cookies for?

Cookies are used to ensure the proper and secure operation of the website, to maintain user sessions, and to manage consent through the CookieYes platform.

We also use functional cookies to store the user's preferred language (RO/EN).

The website also uses statistical/analytics cookies and marketing cookies.

3. What types of cookies do we use?

The website www.cit-one.ro uses the following types of cookies:

- **Strictly necessary cookies** – essential for the proper and secure functioning of the website, including the display and management of consent options through the CookieYes platform.
- **Functional cookies** – allow the website to remember user preferences, such as the selected language (RO/EN).
- **Analytics/statistical cookies** – used to obtain aggregated and anonymized information regarding website usage, solely for the purpose of improving performance and user experience.
- **Marketing cookies** – may be used to deliver relevant content and communications to users, based on their interests.

Analytics/statistical cookies and marketing cookies are used only on the basis of the user's explicit consent, granted via the cookie management banner (CookieYes), and are not activated in the absence of such consent.

4. User consent

Consent for the use of non-essential cookies is obtained through the CookieYes banner displayed upon the user's first visit to the website.

Users may accept, reject, or customize cookie settings directly from the banner and may modify their preferences at any time by accessing the "**Cookie Settings**" section.

Strictly necessary cookies are enabled without consent, as they are essential for the technical operation of the website.

5. How can you manage cookies?

Users may control cookies directly through their browser settings.

Blocking strictly necessary cookies may affect the proper functioning of the website, while blocking functional cookies may prevent the website from remembering language preferences.

6. Third-party cookies

At present, the website www.cit-one.ro does not use third-party cookies.

Should such services be integrated in the future, they will be automatically displayed in the CookieYes banner and included in the updated version of this Policy.
